Please note that the figures in the spread sheet above do not include the diagnosis code for overdose\poisoning as this also includes people who have accidentally overdosed or drunk too much. However, if you feel that you would like this information, then the Trust would be happy to supply it for you.

- 1. How many patients attended A&E due to mental health in each year covering the period financial year 2010-11 to 2014-15? Please break down the statistics into the number per financial year.
